### **PUBLIC POLICY**

#### State Medicaid Spending:

More than 39 million women are now enrolled in Medicaid. One of 10 women in the U.S. receives health care through this program. It is crucial to the nation's family planning. Medicaid covers 20% of women 15-44. Repeal of the Affordable Care Act (ACA) and the House of Representatives American Health Care Act (AHCA) bring dire consequences. Repeal of the Medicaid Expansion and ending federal subsidies for insurance purchases under ACA will leave the most vulnerable uninsured. AHCA defunds Planned Parenthood which provides access to preventive care for millions of women and men. A vote in the Senate is what we need to watch. AAUW opposes the House AHCA because it weakens women's access to affordable quality health care and puts economic security of families in jeopardy. Visit AAUW's the Two-minute Activist. Tell the Senate to protect our care.

#### Mom's Equal Pay Day:

Ironically Tuesday, May 23 is Mom's Equal Pay Day. Mothers made 71 cents for every dollar fathers make. The motherhood penalty impacts hiring, salaries, and promotions. We celebrated Mother's Day. We should be supporting paid parental leave, opposing the proposed comp time legislation that would leave mothers without overtime pay. All women, mothers or not deserve equal pay for equal work. That's what we want for Mother's Day.

#### **Court Allows Unequal Pay:**

Last week the 9<sup>th</sup> U.S. Circuit Court of Appeals ruled employers can pay men and women unequally based on difference in their prior salaries. This overturns a lower court ruling that found that salary differences based on prior pay alone are illegal. It was an AAUW Legal Advocacy Fund plaintiff and AAUW member Aileen Rizo, a math educator who brought this case forward after she discovered that a male co- worker with less experience received a higher salary. Rizo's employer adds 5% to an applicant's previous salary to determine starting wage. This method does not take into account experience needed for the current job posting, or a fair wage for this position. Past discrimination thus follows the employee from job to job.

#### **Bills introduced:**

In the Michigan Legislature, the following bills have been introduced: HB 4510 of 2017 and SB 318 of 2017 amends the Elliot–Larsen Civil Rights Act to increase damages for unequal pay and specifies that the statute of limitations starts from the time the employee learns about the disparity in pay. HB 4516 of 2017 and SB 324 of 2017 amends the Elliot-Larsen Civil Rights Act to prevent an employer from inquiring about past compensation during the application or hiring process. These bills are in committee presently. Hope springs eternal.

## *Special Request* OUR LOCAL SCHOLARSHIP FUND NEEDS YOUR HELP

### Scholarship Funds Down, Tuition Up

As you know, our book sale and some of our other fundraising work benefits our local scholarship fund. It, in turn, "awards monetary assistance to local women who demonstrate a financial need in their pursuit of educational goals at Northern Michigan University." Unfortunately, over the past few years our efforts have not yielded as they did in the past. For example, ten years ago we were able to award \$4500 in scholarships; this year it may be less than \$3000. At the same time, NMU tuition has increased. For the 2010-11 academic year, tuition and fees amounted to \$7500; for the next academic year, a local junior or senior student will pay close to **\$10,800.** We have tried to adjust to these changes by awarding just one scholarship each year, and have done so the past two years.

**Our scholarships are unique** in that we look for applicants whose financial need may include that she

is: divorced, in the process of divorce, separated or widowed; married and the spouse is unemployed or underemployed; disabled or the spouse is disabled; dependent on public assistance; a criminal offender and seeks education as part of her rehabilitation; a single parent; is a displaced homemaker; in a lowerlevel position and would like to obtain credentials to make a professional leap; over 40 years old. Frankly, applicants who meet any of those criteria have been declining in number as tuition rates rise.

Nevertheless, it is still our hope to make a significant dent in the tuition bill of some woman who just needs

a break. To do so, our local scholarship fund needs our help. As we break for the summer, **let's contribute** what we can individually by sending a check to Meredith Kulisheck, 617 Hampton Street, Marquette MI 49855. *(Please write 'scholarship' in the memo line.)* Then combined, our contributions will allow us, as a branch, to make a real difference for a deserving student.
