AAUW's StartSmart TRAINING

Part of the 2018 NMU Women to Women LeadHerShip Workshops

NMU's Women for Women will host their second annual LeadHerShip workshops on Sat 24-Feb-2018 between 9:00AM and 3:00PM. The location will be announced via email to our membership in mid-February.

StartSmart – AAUW's financial negotiations training program – will be conducted after lunch. University women will practice their negotiation style through facilitated discussions and role-play. They will learn the significance of negotiations on closing the gender

pay gap, and they will gain confidence in their ability to identify and articulate their personal work value.

According to AAUW's research on the gender pay gap, women during their first year after college graduation are paid significantly less than their male counterparts are for the same work. Women who negotiate could significantly increase their salaries and obtain better benefits packages.

AAUW-MQT member **Janel Crooks** facilitated StartSmart for Women for Women last year, and she will facilitate the training again this year. Hope for 2018

Women's March

The first anniversary of the 2017 Women's March on Washington renewed hope for the future. It was inspiring to see so many pledged to work on gender equity. The outrage that women shared propelled them to run for office. Let's hope this outrage propels all to the polls in 2018.

Roe V Wade

This year is also the 45th anniversary of Roe V Wade. AAUW supports the right of every woman to access safe affordable, comprehensive reproductive health care. This critical health care component leads to greater economic security for women and their families. However, risks abound.

- The U.S. House of Representatives passed a bill which undermines abortion services.
- The Department of Health and Human Services rescinded guidelines explaining states' efforts to

- block patients' access to Planned Parenthood Health Centers violates federal law.
- HHS expanded providers' ability to refuse access to abortion services, birth control and other health care.

In Michigan

Michigan, HB 450 is an effort to count an embryo or fetus as a person when calculating number of victims of a crime. Michigan already has a law which increases penalties when there is an injury to a pregnant woman. This bill is an effort by antiabortion advocates to criminalize abortion. Access to contraception under the Affordable Care Act has decreased the numbers of unintended pregnancies and abortions. Isn't that what we all want?

Larry Nassar case

Watching the Larry Nassar case unfold is painful. On so many levels we failed these brave young women who courageously came forward to confront this perpetrator and confront all of us with how we failed to protect them. The Michigan Senate unanimously passed SB52 allowing prosecution at any time for second degree sexual conduct if the victim was younger than 16. The bill increases the statute of limitation for the offense from 10 to 20 years or following the victim's 31st birthday. This bill is now in the Michigan House Committee on Law and Justice. Michigan Attorney General Bill Schuette is conducting an investigation into Michigan State's handling of sexual assault claims against Nassar.

The Title IX probe conducted by the University in 2014 cleared Nassar of allegations but did not follow up or enforce recommendations for him to avoid being alone with patients while treating them in "sensitive areas." The patient who reported the abuse in 2014 was provided with only an abbreviated version of the results of the 2014 investigation. That version omitted the finding that by his use of "invasive sensitive procedures" without obtaining patient consent, it opened the practice to liability and exposed patients to unnecessary trauma based on the possibility that they might have perceived the treatment as inappropriate sexual conduct. Twelve reported assaults occurred after 2014.

Transgender discrimination

The Department of Education's Office for Civil Rights declined to investigate 3 cases of discrimination against transgender students because such cases are no longer under their jurisdiction????! Let's hear it for Michigan's own Betsy DeVos.

Maddie is committed to gender equity. She is an advocate for social justice. She has helped mobilized others to email their congressional leaders to support the *Protecting Girls' Access to Education in Vulnerable Settings Act*. This bill urges consideration of educational needs of vulnerable women and girls in designing, implementing, and evaluating U.S. foreign assistance policies and programs.
