PUBLIC POLICY

Please consider putting aside holiday preparations for two important issues

1. Rolling back earned, paid sick leave

The lame duck session of the Michigan Legislature is planning to roll back the earned paid sick leave which is now PA338 of 2018 which requires employers with 10 or more employees to provide 1 hour of sick leave time for every 30 hours worked up to 72 hours per year. Businesses with less than 10 employees are allowed to accrue 40 hours of sick leave per year. This is a public health issue. Without benefit of earned paid sick time employees who can't afford to stay home come to work sick and often are forced to send their children to school sick because they can't afford child care. Nearly 2 million Michiganders are without access to earned paid sick leave.

Because the legislature *can* amend a legislatively voterinitiated law, Governor Snyder could veto a legislative attempt to gut PA 338 of 2018. Tell the Governor and our legislators to keep the recently adopted earned paid sick leave law without weakening amendments. Reject SB 1175 or its equivalent.

2. Title IX is in big trouble

Betsy DeVos released a Notice of Proposed Rulemaking which drastically changes Title IX's protection to survivors of sexual assault and sexual harassment at public schools and universities. Currently, the schools' response must be both prompt and equitable for both parties. This means the standard of proof across the board for either party, accuser or accused, is a preponderance of evidence.

The proposed new rules narrow the definition of sexual harassment so it excludes the abuse students experience. The new rules also limit how schools respond to reports of sexual harassment. They make it harder for students to come forward and obtain the support needed.

These new rules are part of an administrative effort to dismantle Title IX protection. To add your name to a letter opposing these changes, go to aauw.org online. Under the heading "Take Action," click on "Take Action for Title IX." This action is a major AAUW national effort, but the time period in which public comment can be made is fading fast. Please do this now. It will only take a couple of minutes of your time.
