Public Policy News

AAUW announced its ambitious gender policy agenda outlining goals to improve gender equality in education and the workplace. When talking to or listening to candidates, keep these issues in mind.

Economic Security

- 1. Ensure Equal Pay for Equal Work
- 2. Implement Paid Leave and Paid Sick days
- 3. Stop Harassment in the Workplace
- Raise the Minimum Wage and Eliminate the Tipped Minimum Wage
- 5. Close the Retirement Gap
- 6. Protect Pregnant Workers

Education

- 1. Defend and Strengthen Title IX
- 2. Reduce Student Debt
- 3. Expand opportunities for Women and Girls in STEM

Foundation Rights

- 1. Expand and Protect the Right to Vote
- 2. Ensure Access to High Quality Healthcare
- 3. Ratify the Equal Rights Amendment

The Michigan AAUW Executive Board endorsed Fair and Equal Michigan, the proposed voter-initiated law to add LGBT protection and a definition of religion to Michigan's civil rights law. National AAUW also approved this endorsement. The proposed law would define sex as including gender, sexual orientation, gender identity or expression. The definition of religion includes religious beliefs of an individual. There will be a petition available at our March meeting for you to sign; Fair and Equal Michigan has until Mar 27 to compile 340,047 Michigan voters' signatures.

The Bureau of Elections and the Board of State Canvassers determines if enough signatures are valid. The Michigan Legislature has 40 days to adopt the proposed amendment to the act without changes. I find this funny because the Michigan Legislature has failed to act on this issue for 37 years. If the legislature does not act or rejects the proposal, it is submitted to Michigan voters for approval November 3, 2020. Or the legislature can propose its alternative to the voters. Major employers and AFL-CIO endorse this. Recent polling by the non- partisan Glengariff group showed 77% of voters support this measure AAUW hopes members will be inspired to help with petition signature gathering and information to pass the measure.

Sara Cambensy is one of the co-sponsors of HB5272. This bill would expand the number of individuals allowed to carry a weapon in a no-carry zone to include people who petitioned for a personal protection order (PPO). Currently, if a person holds a Concealed Pistol License, he or she cannot carry the pistol concealed in places such as a day care center, a church or a bar. These are no-carry zones or weapon free zones. The copy of the PPO would serve as proof of qualifying for the exemption. I understand that this is an effort to protect survivors of domestic violence. However, something that would do more to protect domestic violence survivors and the general public would be passage of red flag laws. It would help if those convicted of domestic violence or against whom a personal protective order was issued were not given access to guns. HB 5272 is on a fast track and Representative Robert Wittenberg's red flag law requiring firearm background checks, HB 5275, probably will not see the light of day in the present legislature.

I look forward to seeing you at our March 12 AAUW meeting on literacy.

FROM THE ARCHIVES

A feature column highlighting a bit of our AAUW history from our records held by the Central Upper Peninsula and Northern Michigan University Archives. What archives treasures would you like to see featured in the newsletter? Contact Emily Tinder (<u>etinder@nmu.edu</u>) to share your ideas!

AAUW members in Marquette have a long-standing history of performance, and a good portion of it has been preserved in the AAUW of Marquette records, kept at the NMU Archives. Members are aware of the recent production of The Remarkable Susan, but other performances span back well into the 1960s and '50s. They often included the work of both members and local community members and seemed to always be casted entirely of women. Seeing the photos really brings the plays to life and reading announcements and reviews from the accompanying newspaper clippings makes the experience even more fun.

Puss In Boots, **performed in 1956**, was the oldest set of photos in the scrapbooks. Members can be seen in costume, both as a group and in individual scenes from the performance. The fuzzy cat costume really speaks to me!

Hansel and Gretel, performed in March of 1958, has one of the larger sets of photographs and newspaper articles. It seemed to have been quite a large production, with 13 fully costumed actresses and costume, tickets, and scenery "chairmen" for the production. In the photos, Hansel and Gretel, plus "Witch Wicked," are admiring their gingerbread house. Other scenes show each cast member in their costumes, and some group shots of the play are included as well.

The first set of color photographs comes with the production of *Snow White* in 1971. In this activity, marionettes instead of human actors were used (except, of course, for Marion Sonderegger, dressed as a fairy godmother.) The pictures show behind the scenes as well as the puppets and sets themselves, all handmade and very detailed! I enjoyed these photos the most as you can really see the whole scope of the production rather than just staged shots.

Surely these community events were a fun and entertaining way to keep everyone engaged with AAUW. Bravo to all the women who helped in any of them, past or present!
