Pass the Heroes Act Please

In the face of so much suffering, it is a disappointment that the Senate adjourned for summer recess on August 13, 2020 without passing the Heroes Act or some alternative legislation. The Health and Economic Recovery Omnibus Emergency Act better known as the Heroes Act passed the U.S. House of Representatives May 15, 2020. It provides needed support to states, families and individuals. The Act expands paid sick days, unemployment compensation, nutrition and food assistance, housing assistance and funding for childcare. It tries to address educational disparities by ensuring students have access to distance learning, school meals and resources for schools to open safely. The act provides up to \$10,000 in student loan relief to borrowers who are economically distressed. The Heroes act supports states in their effort to provide fair and accessible election and voter access.

Paid Leave

The U.S. does not guarantee paid annual leave, time off for illness, care of a family member or paid parental leave. The majority of developed countries world- wide do. More than 34 million or 1/3 of the U.S. workforce can't **earn** sick days.

The Family and Medical Insurance Leave (FAMILY ACT) also known as H.R.1185/S.463 would create a self- funding paid family and medical leave insurance program. Many women workers delay health care for themselves because they can't afford to take time off work. They may send their children to school sick because they can't afford to stay home and care for them. Paid leave means workers will not have to choose between their job and health. This is a public health benefit for all because workers will be allowed to stay home and get well instead of spreading illness.

AAUW is committed to social and physical wellbeing of all people. AAUW supports the Healthy Families Act which would ensure workers in businesses with 15 or more employees can earn up to 7 job-protected paid days off.

Thank Governor Whitmer for signing an Executive Order on August 27 which prohibits employers from discharging, disciplining or retaliating against employees who stay home when they are sick to recover from their own illness. Actually, this measure will save lives and reduce spread of COVID-19. Employees who stay home are to be given medical leave

These measures just chip away at ameliorating the immense challenges many in our country are facing, VOTE and be sure everyone you know votes. If you are voting absentee mail your ballots 2 weeks prior to Nov 3 or deliver them to the clerk's office. In Michigan they must be received by Nov 3.
