# AAUW WORKSHOP FACILITATOR to be FEATURED at NOVEMBER 19 MEETING.

November 19, 7:00 pm at the Federated Women's Clubhouse, our branch will be privileged to hear Kerri Sleeman, Executive Director of Facilities at Michigan Tech University and a champion for pay equity.

Kerri testified before the Senate Health, Education and Labor and Pension Committee as Congress considers the Paycheck Fairness Act. She testified as an employee who had experienced pay discrimination when as a supervisor, she discovered that several male employees she was supervising were more highly paid with lesser qualifications.

Kerri now also serves as a regional field manager for AAUW's Start Smart salary negotiation workshop. She will serve as the facilitator for the Start Smart Workshop presented November 6 at Northern Michigan University. The workshop provides strategies to new job seekers to obtain an appropriate wage.

Bring a guest to hear Kerri discuss the wage gap between men and women in Michigan and the nation.

### **GLIMMERS OF HOPE FOR PAY EQUITY**

California passed the **California Fair Pay Act** requiring that women be paid equally for work that is similar to male colleagues. It ensures that employees who discuss wages or inquire about pay practices will not face retaliation. The bill also clarifies rules around employees recovering wages lost due to gender discrimination. It clarifies the employers' ability to defend such allegations. The California Chamber of Commerce supported this bill which is similar to the bill Paycheck Fairness Act SB 862/HR 1619. Although partisan posturing and gridlock have prevented Congress from passing this national legislation, California is showing us a *glimmer of hope*.

Another *glimmer* came when the U.S. Department of Labor Wage and Hour Division found more the 270,000 workers were owed \$240 million in back wages due to employers' labor law violations, it created an online tool called Workers Owed Wage (WOW) allows workers to discover if the Wage and Hour Division is holding wages owed to them. At http://webapps.dol.gov/wow/ workers can search for their employer and put in their own name so they can be contacted about owed wages. The program was launched earlier this year and has returned \$800,000 in owed wages.

However, although the U.S. Census tells us that the mean wage for women workers is up 3 cents from 76 to 79 cents for every dollar earned by men (*a very slight glimmer*), at that rate, equity would still take 100 years. So, that Paycheck Fairness Act is much awaited.

Be sure to attend our November 19 Marquette Branch meeting **and bring a guest** to hear Kerri Sleeman discuss pay equity. Perhaps she'll have another glimmer of hope she can share with us.
