
Join Dr. Liz Wuorinen online on Thursday, April 21, at 7:00 for a discussion of equity in sports, exercise science, and outdoor recreation. Dr. Wuorinen, Associate Dean of the <u>School of Health and Human</u> <u>Performance</u>, has a Ph.D. in Exercise Physiology from the University of Michigan - School of Kinesiology. NMU's School of Health and Human Performance has several popular programs, including athletic training, outdoor recreation, and exercise science. The faculty, including Dr. Wuorinen, are active researchers who engage their undergraduate and graduate students in hands-on learning. We've invited her to frame the conversation around these questions:

- What changes have we seen in female participation in sports in the last 10 years?
- How does exercise science research reflect women's participation and health?
- Where do we have opportunities to improve representation in athletics and exercise science research?
- People of color are less likely to engage in outdoor recreation. What impact does that have on our communities? What opportunities do we have to narrow the adventure gap?

# **Public Policy News**

### *".....Real change... happens one step at a time"* <sub>RBG</sub>

Sometimes the steps appear to be going backward. This month there are steps forward.

Ketanji Brown Jackson's confirmation brings the first black woman justice to the Supreme Court. Ketanji Brown Jackson said it has taken her family one generation to go from segregation to the Supreme Court. She uniquely brings to this body, her experience as a trial lawyer, a public defender, and her service on the U.S. Sentencing Commission. Although her appointment will not change the liberal- conservative balance of the court, her dissents might pave the way to fairer legislation.

The Violence Against Women's Reauthorization Act of 2022 passed. This VAWA expands criminal justice jurisdiction to Tribal Courts to cover non- native perpetrators of sexual assault, domestic violence, stalking, child abuse who commit these crimes on tribal land. These perpetrators previously escaped prosecution because of jurisdictional gaps. VAWA increases support for LGBTQ individuals. It creates federal civil cause for action for people whose intimate visual images are disclosed without their consent. This reauthorization includes Kayden's law, the Keeping Children Safe from Family Violence Act which incentivizes family court reform prioritizing child safety over parental rights.

Unbelievably the boyfriend loophole was **not** plugged in this reauthorization. This loophole allows dating partners to have a gun while married abusers can't. Women are just as likely to be killed by a dating partners as spouse, but the Senate refused to include this. This part of the legislation was the sticking point which prevented reauthorization for almost a decade.

Are we there yet? No but a few steps forward were taken.

Governor Whitmer filed a lawsuit with the Michigan Supreme Court to protect legal abortions in Michigan. The Michigan Supreme Court is asked whether the State Constitution protects the right to abortion. If Roe is overturned, abortion would be illegal in Michigan even in cases of rape and incest because a 1931 law would take precedence. Roe v Wade rendered this law unconstitutional in 1971. Governor Whitmer's lawsuit asks the court to stop enforcement of this 1931 abortion law. Let's hope the Michigan Supreme Court finds the abortion ban violates the Michigan due process clause which covers the right to privacy and bodily autonomy and the ban violates Michigan Equal Protection clause denying women equal rights.

There are 16 proposal which may find their way to the November 2022 ballot. AAUW's Mary Pollock provided a color-coded guide to help you know which ones Michigan AAUW supports. We are including this on page 6 in this newsletter.

**Promote the Vote 2022** is a petition to amend the Michigan Constitution. If enacted this amendment ensures voters can vote without harassment, intimidation. and interference. The proposal prohibits use of laws, rules or procedures which interfere with registered Michigan citizens right to vote.

Military and overseas votes will be counted if postmarked by election day. It allows voters to prove their identity in person by showing photos issued by federal, state, local or tribal governments or education institutions or by signing an affidavit verifying their identity. It requires election audits be conducted in public by state and county election officials based on methods established prior to the election. This preserves the ballot chain of custody. The measure provides 9 days of early voting in person for 8 hours a day before federal or state election. It requires 1 drop box per municipality or at least 1 drop box for every 15,000 voters in the municipality.

If this measure passes these fail-safe provisions will be in our Michigan Constitution in perpetuity. By July 11, 425,059 signatures are required to get this on the November 2022 ballot. Contact Ruth Ziel (rziel@gmail.com) or Marge Forslin (mfoslin2@charter.net) leaders in our local effort,

### **Martha Griffiths Award**

#### Honoring an Influential Michigan Woman Legislator

The call for the 2022 Martha Griffiths Award received eight inspiring nominations. The award is given to a high-achieving NMU undergraduate who will earn an associate or bachelor's degree in 2022 and who has demonstrated leadership and

commitment to women's rights, community involvement, and deep interests in issues to advance gender equity through civic, political, and/or cultural initiatives.



This year's award recipient is Jenna Chappell who will graduate *cum laude* in April 2022 with a double major in <u>Criminal Justice</u> and <u>Anthropology</u>. Jenna is president of Feminism for All, formerly known as Women for Women. She worked to change the name to make the group more inclusive and welcoming to trans and non-binary members. As a leader in *Feminism for All*, Jenna helped to organize the Annual Slut Walk in 2020 and 2021 to stand with survivors of sexual assault and to make the point that clothing does not equal consent. She facilitated a Voter Registration and Voting Information Workshop, Fat Liberation Workshop, and Wage Gap Bake Sale with proceeds going toward Reproductive Rights in Texas.

She presented on sexual assault awareness with the Sexual Assault Response team from the Marquette Women's Center, and she partnered with the Women's Center to organize a purple out in October to raise awareness for domestic violence.

In addition, Jenna was a student athlete on the NMU Women's Soccer team (Fall 2018 – Fall 2020). She frequently draws attention to gender discrimination in athletics related to legislation targeting trans athletes and the US Women's National Soccer Team's fight for equal pay. We congratulate Jenna on her many accomplishments and upcoming graduation. About <u>72.1%</u> of Anthropology majors are female. In contrast, the percentage of female full-time law enforcement officers has been low for several decades (<u>US Dept</u> <u>of Justice, 2019, p. iii</u>). In 2020, only <u>13.1%</u> of fulltime law enforcement officers were female.

The NMU community provided outstanding nominations across many NMU departments and units. This year's Martha Griffiths Award competition was incredible. Acting President Kerri Schuiling wrote, "And again, you find an incredibly talented and outstanding person to receive this award; one who is truly deserving. Thank you for all of your work on this and congratulations to the awardee! Kerri".

The Martha Griffiths Award comes with \$500.00 in cash, publicity in the local newspaper, and a framed certificate with Jenna's name as recipient of the 2022 Martha Griffiths Award.

Jenna will join us at our "Equity in Athletics" program via Zoom on April 21 at 7:00pm.

### Read the 100-word summary on the petition before signing.

- 1. Unlock Michigan 2\* limit emergency authority of public health officials
- 2. Secure MI Vote\* reduces access to absentee voting, stricter ID requirements
- 3. Michigan United\* restore good time credit for prisoners
- 4. Yes on National Popular Vote\*\* (suspended campaign until 2024)
- 5. Let MI Kids Learn A and B\* public funding of private education with tax credits
- 6. Michiganders for Fair Lending\* cap interest rates on payday loans at 36%
- 7. Audit Michigan\* require private "forensic" audit of 2020 and future elections
- 8. Raise Michigan\* raise minimum wage to \$15/hour by 2027
- 9. Reproductive Freedom for All\*\* pro-choice, repeal contradictory laws
- 10. Promote the Vote 2022\*\* voting rights and ballot counting protections. Counteract Secure MI Vote and Audit Michigan.
