Report from the Battlefield

ERA ratification

In the never-ending war on women, the DC Court of Appeals is hearing Illinois v Ferriero, a lawsuit Nevada and Illinois Attorney Generals are bringing against the National Archivist for failing to publish the Equal Rights amendment to the U.S. Constitution. Virginia's newly elected Attorney General Jason Miyares dropped out of the suit because he himself is opposed to ERA. Really!

All of the requirements to become an Amendment have been met. The final step to make a constitutional amendment official is for the U.S. Archivist to verify ratification, then draft a formal proclamation which certifies the amendment is valid and now is part of the constitution.

Two hundred constitutional scholars insist ratification is valid. The office of Legal Counsel issued an opinion that Congress could take action on ratification of ERA. The House passed two resolutions in February 2020 and in March 2021 lifting the timeline. The Senate failed to pass this. The so-called deadline was never within the power of Congress to impose. The states did not approve an ERA ratification time frame. So, this deadline is invalid, unenforceable. Once a ratification is made it cannot be revoked. The Biden administration and Merrick Garland failed to correct the erroneous Trump administration's legal opinion. The Justice Department has been said to look to the judicial and legislative branches for an opinion as to what the executive branch should do. How about each branch of government doing their direct duty and upholding the Constitution. The Biden Administration has the duty to publish the Equal Rights Amendment. No other branch has that authority. Biden can solve the problem by issuing a direct order to publish the amendment. This is a cruel game being played.

We have one other path--to get a resolution passed by both the House and the Senate compelling the archivist to make ERA the law of the land. We have to have Democrats hold the house, win 52 seats in the Senate remove the filibuster, then pass the compelling legislation.

Eighty five percent of the member nations of the U.N have gender provisions in their constitutions protecting equal rights. The U.S. Constitution does not mention the word women. We have waited 100 years for equality. In the midst of the present war on women we have to VOTE and insist

the time is NOW to

enact ERA. We are tired of expressions of concern and delays and artificial barriers

PROMOTE THE VOTE

As we all know, there is a midterm election coming up November 8th roughly 6 weeks away. There is a lot on the ballot, a lot at stake. My focus is Proposal 2, a voting rights initiative known as PromotetheVote22. A number of AAUW-MQT members gathered signatures for this initiative. We were part of a force that gathered 669,972 signatures to get this on the ballot in Michigan. We needed roughly 425,000 valid signatures. The SOS office certified 665,000 of those signatures and we did it in about 60 days. This ballot initiative is endorsed by AAUW of Michigan as well as the League of Women Voters and many other organizations.

Now for the hard part: Informing people of this constitutional proposal and encouraging people to vote YES. This measure, if it passes, will enshrine voting as a fundamental right of ALL registered voters in this state. So regardless of who you are, what you look like, where you live, able-bodied or disabled, who you want to vote for, you will have equitable access to the ballot either in person or by mail with confidence that your ballot will be fairly counted.

Contrary to many of the ads against this proposal, our voter ID laws which have been in place since

2007, will still be in place and placed in the state constitution. Registered voters will need a picture ID to vote in person, but if they don't have one, they will need to sign an affidavit attesting to their identity. All voters still need to have a signature match to vote by mail. Please note, this ballot initiative covers nothing about voting rights of felons or ex-cons. These are covered by an entirely different set of rules.

There is an informative overview of all 3 statewide ballot initiatives: Proposals 1, 2, and 3 at VOTE411.org for put out by the League of Women Voters of Marquette County.

We are asking AAUW members to take 10 flyers each and pass them out to family, friends, neighbors, etc. encouraging them to vote YES. If you think it would be easier, you can email a flyer to family and friends who vote in this state encouraging them to vote YES on Prop 2. Many members have already taken paper flyers and/or have committed to emailing a flyer. I have a copy of the email flyer I can send to you. Please help.
