On the student loan front

Governor Whitmer signed an executive order telling the Department of Treasury to look into the benefits of the state being the student loan organization. It might permit student loan applicants to obtain lower rates. This is a proactive measure on the Governor's part. The U.S. Supreme Court may strike down Biden's student loan forgiveness program. Other agencies like the Department of Insurance and Financial Services and the Office of Rural Development are looking at ways to lower borrowing costs and student loan debt.

Parental Consent for Abortion laws...

...may see some changes. The current law requires one parent to consent to a minor obtaining an abortion. Judicial bypass from probate court is a burdensome option. Children in foster care find it harder to get consent and access as do survivors of incest and abuse. Some minors fear being kicked out of the house if they are pregnant. The mandate passed in Proposal 3 supports more compassionate change. The American Medical Association, the College of Obstetrics and Gynecologists and the American Academy of Pediatrics policy since 1989 states adolescents under the age of 18 should have the right to legal, confidential, medical and surgical abortion care and counseling. Most teens voluntarily involve a parent or trusted adult regarding terminating a pregnancy. Planned Parenthood and ACLU support changes in parental consent. PPAM recommends removing the requirement for consent from a parent or legal guardian and removing the 24-hour waiting period for an abortion. These recommendations are trying to ensure vulnerable populations can access reproductive care with minimal barriers Let see where the Michigan legislature is headed.

Conversion therapy

Conversion therapy is based on the outdated belief that being LGBTQ+ is something in need of fixing. Twenty-one states have banned conversion therapy. Senator Mallory Mc Morrow (D Royal Oak) sponsored SB348 and SB349. HB4616 and HB 4617 are sponsored by Felicia Brabec (D Ann Arbor) and Jason Hoskins (D Southfield). These bills add a section to the mental health code banning any practice or treatment by licensed mental health providers that seek to change an individual's sexual orientation or gender identity. Providers who violate the prohibition would face licensing sanctions or disciplinary action. "Kids subjected to conversion therapy attempt suicide more than double the rate of LGBTQT+ peers," Mc Morrow said." This junk science amounts to nothing more than child abuse." The American Academy of Child and Adolescent Psychiatry said conversion therapy lacks scientific credibility. A 2022 National survey by the Trevor Project on LGBQT Youth Mental Health found 17% of LGBTQ youth reported being threatened with or subjected to conversion therapy. These bills are presently in committee but there is a good chance of their passage.

ERA Oops, I misspoke regarding ERA at the Board meeting. Sorry, I am guilty of wishful thinking. When I went back to the email, I found I had misunderstood. House Continuing Resolution 3 (HCR 3) passed the Michigan House. The Senate Government Operations Committee is where this resolution is now. Mary Pollock, AAUW's Government Relations Coordinator will communicate with the Chair of this committee

Winnie Brinks (D Grand Rapids) to say that AAUW would like to see it pass and determine how we might help it along the way. It calls on the Archivist of U.S. to certify and publish ERA as the 28th Amendment of the U.S. Constitution and calls on Congress to declare ERA ratified. Do you think this push by the Michigan Legislature will get Congress to act on ERA? When I look at the craziness in the rest of the country the Michigan Legislature makes me proud.

AAUW MQT Financial Report April through May 20, 2023

The balance in our checking account April 1,2023 was \$16,759.34. As of May 20, 2023 our balance was \$20,723.40. After accounting for restricted income and fixed expenses for a total of \$\$6,137.67, we have at our disposal \$14,585.73 as of May 20,2023.

Combined income for April and May is as follows. Booksale was \$4098, NMU scholarship donation of \$76, National and state dues of \$948, local and clubhouse dues of \$467, general fund donation of \$93 and interest of \$6.44 for a total income of \$5,688.44.

Expenses for this same time period were, book sale \$380.60, National and state dues payment of \$864, Director and Officer liability insurance payment of \$348, food for the May general membership meeting of \$106.78 and caretaker fee of \$25 for May meeting for a total of \$2,588.38.

There is minimal activity in our STEM account. As of April 1, 2023 the balance was \$10,734.79. Our only income was interest of \$4.12 and no expenses. Our balance as of May 20, 2023 was \$10,738.91

Our NMU Scholarship fund has a balance of \$4760.

Democracy Academy Project

At our last board meeting our board supported partnering with Voters Not Politicians for the pilot program Democracy Academy Project. This came about in part as an outgrowth of our May membership meeting in which members indicated partnering with other organizations was an interest.

Voters Not Politicians (VNP) is a non-partisan organization championing voting rights in our state. VNP was responsible for the successful ballot initiative to end gerrymandering in this state in 2018 as well as expanded voting rights through a successful ballot initiative known as *Promotethevote22* in 2022. Marquette was chosen this year as a pilot site by VNP for the Democracy Academy Project. The purpose of the project is to address low voter turnout for local elections by understanding why this may be so and develop strategies to improve voter turnout. It will encompass 2 sessions.

Our role as a partner will be to help find a facility to hold the sessions, encourage participation among interested AAUW members and the community at large and arrange for food for the sessions. I have been assured there is no financial obligation for our branch. Publicity, room rental, food costs, printing costs etc. will all be handled by VNP. It is a way for AAUW MQT to be more visible in our community. It is looking like the Academy will take place toward the end of summer before the November election. As I receive more information regarding a time frame, I will email the membership. We do have NMU students who have expressed interest in the project as well. Hopefully some of you are interested and willing to lend a hand.
