## **Public Policy News**

# President Biden Expanded Access to Contraception

Federal agencies were issued guidelines to make no-cost contraceptives more available under the Affordable Care Act. Access to contraceptives was expanded for federal employees. Health and Human Services reminded insurers of their obligation to provide no cost contraceptive coverage. The Emergency Medical Treatment and Labor Act requires hospitals to provide emergency abortions nationwide including the 21 states where the procedure is limited or banned.

In Michigan, passage of Paid Family Leave does not look promising.

Governor Whitmer is proposing a state income tax credit of \$5000.00 for family caregivers. It is an effort to cover costs like counseling, nursing respite care, and transportation and put more money in people's pockets. However, this does not answer the problem presented when people come to work sick because they cannot afford to take time off work. This is a public health issue.

The *Healthy Families Act* H.R. 3409/S.1664 would allow employees to earn paid sick days they could use for their own sicknesses or provide care for a sick family member. It would include time for recovery from domestic violence, sexual assault and stalking. Caring for a sick child should not risk or cost you your job. Urge members of Congress to support the Healthy Families Act
