## **Equal Pay Day Event**





#### A Valentine's Day Public Policy Message

**Have you heard? The debate is over.** The Equal Rights Amendment is the 28<sup>th</sup> Amendment to the Constitution. On January 17 President Biden avoided telling the Archivist to publish the ERA and declared "I affirm what I believe and what three fourths of the states have ratified: the 28<sup>th</sup> Amendment is the law of the land, guaranteeing all Americans equal rights and protections under the

law regardless of their sex". According to Laurence Tribe and other legal scholars, President Biden's pronouncement fulfills the function of the Archivist to inform the nation that the amendment is in force!!!! Now we can use ERA as the bedrock law to assure gender equality. On the other hand, there is confusion. Biden could have ordered the Archivist to publish ERA, that would have triggered a legal battle with Republicans. The time limit issue is not mentioned in the Constitution and this document does not give Congress the authority to limit the states' ability to ratify once the amendment is proposed. There is no way for states to rescind their ratification in the Constitution. Does Biden's statement supersede the Archivist refusal to publish the ERA as part of the

Constitution? Do we have a leg to stand on? In this search for good news, take it for what it is worth. If we keep saying it is the law of the land, so be it.

It is hard to watch the destruction of the rule of law, the demolition of guard rails that protect our country and its citizens. The nominees for the cabinet have been alarming. AAUW opposes the nomination of Linda McMahon for Secretary of the Department of Education because she has no significant background in education, school administration or civil rights. She supports policies that undermine civil rights and public education for all, would use vouchers and public funds for private schools, would roll back Title IX protections and cut financial aid programs. Linda McMahon is a

rubber stamp for Donald Trump and will do what she can to dismantle the Department of Education. **Please take the time to contact the <u>Two Minute Activist at aauw.org</u> and send a letter to <b>our Senators to oppose her nomination.** Urge them to reach across the aisle to encourage other senators to join them in opposing the nomination of Linda Mc Mahon. The Department of Education announced it has taken action to eliminate Diversity Equity and Inclusion (DEI) initiatives. They have removed guidance documents, reports, training materials which mention DEI, they put employees charged with leading DEI initiatives on paid administrative leave. They are working to "end discrimination based on race and use of harmful race stereotypes "within the agency and throughout the American education system.

The Trump administration is supporting Title IX guidelines of **2020**. They have eliminated the recent guidelines drawn during the Biden administration which were kinder to survivors of rape and sexual harassment and replaced them with the 2020 guidelines.

The statement that the IRS will not discriminate has been removed from the IRS website. This administration has taken a tactic of promoting so many Project 2025 initiatives at once we don't know where to turn next. – Karlyn Rapport, Public Policy

## Women's Federated Clubhouse Ad Hoc Committee

As you may know, the Women's Federated Clubhouse is a historic, 140-year-old building with a rich history of women's activities in Marquette. The Clubhouse has formed an ad-hoc committee (comprised of members from the Clubhouse groups) to brainstorm ideas for improving and sustaining the location for the future. Bringing attention to the Clubhouse as a venue is a top priority. The group is considering activities featuring the Clubhouse to help raise community awareness of the facility (Hot Chocolate for the UP 200, host a Music on Third group during the summer, pop-up art show, folk music, small presentations/talks, etc.). Estimates for updates, renovations, and structural improvements are being sought. Partnerships with other groups may provide support for future sustainability and conversations with several organizations are ongoing.
